- Official identification:
  - I.D. / Residence permit
- Certificate of registration from Citizens Registration Office
- Qualification certificate for the integration course / Vocational German language course:
  - permit or obligation to attend an integration course or vocational language course
  - issued by the Foreigners' Office, Jobcenter, Federal Employment Agency, BAMF or social welfare office
- Documents for cost exemption:
  - Jobcenter (SGBII benefit notification)
  - Social benefits (e.g. housing allowance, child supplement)
  - Federal Employment Agency (ALGI benefit notification)
  - Proof of salary if employed on low income

## Lessons per week and times:

20 to 25 lessons at 45 minutes each  
From Monday to Friday, in the morning or afternoon

## Duration of course:

- General integration course approx. 9 months
- Integration course for young adults approx. 12 months
- Integration course including literacy skills approx. 18 months
- DeuFöV A2, B1, B2, C1 approx. 4-5 months

## General integration courses

For everybody from 27 years up who is able to read and write the Latin characters.  
It starts with A1.1 / 6 modules at 100 lessons each + orientation course at 100 lessons

## Integration course for young adults

The Federal Office for Migration and Refugees offers integration courses for persons up to 26 years.

It starts with A1.1 / 9 modules at 100 lessons each + orientation course at 100 lessons

## Integration course including literacy skills

These courses are for people who are not able to read and write (the Latin characters).  
9 modules at 100 lessons each + 3 modules repetition at 100 lessons each + orientation course with 100 lessons

## DeuFöV - Vocational German language courses

The Federal Office for Migration and Refugees also offers Vocational German language courses for participants who have already reached B1 / B2, or who did not reach level B1 after participating in the integration course.

Basic courses B2 (500 lessons) and C1 (400 lessons); special courses A2 and B1 at 400 lessons

Deutsch-Test für Zuwanderer A2-B1 (DTZ / g.a.s.t.); Leben in Deutschland (LiD)

Vocational German language course:

telc Deutsch-Test für den Beruf (DTB) A2 / B1 / B2 / C1

## Participation and costs – Integration courses:

- Self-pay participants:  
458,- € per module excl. examination fees
- With permit or obligation issued by the Foreigners' Office or BAMF:  
229,- € co-payment per module (2,29 € per lesson)
- With permit or obligation issued by the Foreigners' Office or BAMF while employed on low income:  
0,- € co-payment per module (cost exemption on application)
- With permit or obligation issued by the Foreigners' Office or BAMF while on benefits:  
0,- € co-payment (cost exemption on application)
- With obligation from Jobcenter or social welfare office:  
0,- € co-payment (cost exemption)

## Participation and costs – Vocational German language courses (in accordance with section 45a):

- With permit from Jobcenter:  
0,- € per module
- With permit from Federal Employment Agency:  
242,- € co-payment per 100 lessons (2,42 € per lesson)  
0,- € per module when there is no employment liable to social security

## Examination fees

- DTZ (A2-B1): 150,-€
- Test Leben in Deutschland: 25,-€
- Telc DTB A2 / B1 / B2 / C1: private payers not permitted
